Dr. Jan Angstrom is associate professor and director of studies in the Department of Peace and Conflict Research, Uppsala University, where he is leading two research projects on the conduct of modern war. He has previously held positions at Mid-Sweden University and Swedish National Defence College. He received his Ph.D. from the Department of War Studies, King's College, London, in 2006 and holds a master's degree in international relations from Stockholm University. He has published six books, of which the latest, co-edited with Isabelle Duyvesteyn, is *Modern War and the Utility of Force: Challenges, Methods, and Strategy* (Routledge, 2010). His articles have appeared in *Security Studies*, *International Relations*, *Small Wars & Insurgencies*, *Civil Wars*, *European Political Science*, *Cooperation and Conflict*, *Studies in Conflict and Terrorism*, and the *Proceedings and Journal of the Royal Swedish Academy of War Sciences*, among other journals. He is co-editor of the journal *Cooperation and Conflict* (SAGE).

Dr. David Betz is senior lecturer in the War Studies Department at King's College, London, where he heads the Insurgency Research Group. He created and is academic director of the unique, wholly-online War in the Modern World MA Programme. He has advised the British Ministry of Defence on Counterinsurgency and Stabilization Doctrine and Cyber Security; NATO ISAF on strategic communications, counterinsurgency, and countering corruption; and the US Army TRADOC on the most recent Army Capstone Concept. He is a Senior Fellow of the Foreign Policy Research Institute and a member of the International Institute for Strategic Studies, which will publish his book *Cyberspace and the State* in 2011. He has published articles on strategy, insurgency, and counterinsurgency, information warfare, and civil-military relations in *Armed Forces and Society*, *The Journal of Strategic Studies*, *Contemporary Security Policy*, and *Orbis*, as well as many chapters in edited books.

Dr. Efrat Elron is a research fellow at the Centre for Global Workforce Strategy at Simon Fraser University in Vancouver. Dr. Elron specializes in the management of intercultural interfaces within and between organizations and militaries, leadership and teamwork, and the organizational and strategic effectiveness of peace and stability operations. Dr. Elron earned her Ph.D. in organizational psychology from the University of Maryland and has served on the faculties of Tel Hai Academic College and the Hebrew University's School of Business Administration. She has also been a senior fellow at the International Peace Institute and a research fellow at the NATO Defense College in Rome. Dr. Elron is currently investigating the effects of intercultural interoperability and leadership on mission effectiveness in UNIFIL, and is heading a multinational project looking at the mission from multiple national, regional, and international perspectives.

Dr. Theo Farrell is Professor of War in the Modern World in the Department of War Studies at King's College, London, and Vice Chair of the British International Studies Association. He has authored or edited eight books and dozens of research papers on military affairs, security studies, and international law. He is a former associate editor of *Security Studies* and *Review of International Studies*, and former chair of the International Security Studies Section of the International Studies Association. He has held visiting fellowships at Stanford University and John Hopkins University. Professor Farrell is an advisor to the British government on operations in Afghanistan and was invited by the ISAF Commander, Gen. Stanley McChrystal, to join a strategic review of the campaign in January 2010. In October 2010, he undertook a theatre-wide assessment for the Commander of ISAF Joint Command, Lt. Gen. David Rodriguez. He is currently completing a book with Sten Rynning and Terry Terriff on army transformation and writing a military history of the British campaign for Helmand Province, Afghanistan.

Dr. Adam Grissom is visiting professor of security studies at Georgetown University's Edmund A. Walsh School of Foreign Service where he teaches courses on strategy and social science methodology. His research focuses on military innovation, small wars, and security cooperation. Recent publications include, "Making it Up as We Go Along: State-Building, Critical Theory, and Military Adaptation in Afghanistan" in *Conflict, Security, and Development*; and RAND monographs on the future of unconventional warfare, non-standard rotary-wing operations, and the Afghan National Security Forces. Dr. Grissom has advised commanders on the ground in Afghanistan, Iraq, and the Horn of Africa. He is a graduate of Augustana College in Rock Island, Illinois, and holds a Master in Public Policy from Harvard University's Kennedy School of Government, and a Ph.D. in war studies from King's College, London.

Dr. Nan Li is associate professor in the Strategic Research Department of the US Naval War College and a member of its China Maritime Studies Institute. He has published extensively on Chinese security and military policy. His writings have appeared in *China Quarterly*, *Security Studies*, *China Journal*, *Armed Forces & Society*, *Issues and Studies*, *Asian Security*, *Naval War College Review*, *US Naval Institute Proceedings*, and many others. He has contributed to edited volumes published by RAND Corporation, National Defense University Press, Clarendon Press, M.E. Sharpe, US Army War College, and National Bureau of Asian Research. He has also published a monograph with the US Institute of Peace. He is the editor of *Chinese Civil-Military Relations* (Routledge, 2006). His most recent publications include *Chinese Civil-Military Relations in the Post-Deng Era: Implications for Crisis Management and Naval Modernization* (China Maritime Studies Series No. 4, US Naval War College Press, 2010); and *China, the United States, and 21st Century Sea Power* (US Naval Institute Press, 2010), co-

edited with Andrew S. Erickson and Lyle J. Goldstein. Nan Li received a Ph.D. in political science from the Johns Hopkins University.

Dr. Daniel Moran is professor of international history in the Department of National Security Affairs at the US Naval Postgraduate School. He was educated at Yale and Stanford Universities, and has been a member of the Institute for Advanced Study at Princeton University and professor of strategy at the Naval War College. Professor Moran teaches courses and supervises doctoral research in strategic theory, American foreign relations, environmental and energy politics, and the history of European empires and decolonization. He is the author or editor of many books and articles in these fields, including most recently *Climate Change and National Security: A Country-Level Analysis* (Georgetown University Press, 2011), and *Clausewitz: The State and War* (Franz Steiner Verlag, 2011).

Dr. David Johnson is a senior researcher at the RAND Corporation and also had a 24-year US Army career, retiring as a colonel. Dr. Johnson received his Ph.D. and Master of Arts degrees in history from Duke University. He also has master's degrees from the US Command and General Staff College and the Industrial College of the Armed Forces, as well as a bachelor of arts in history from Trinity University. He is the author of numerous books, articles, and reports including: *Fast Tanks and Heavy Bombers: Innovation in the U.S. Army, 1917–1945* (Cornell Studies in Security Affairs, 2003); *Learning Large Lessons: The Evolving Roles of Ground Power and Air Power in the Post–Cold War Era* (RAND Corporation, 2007); and *Military Capabilities for Hybrid War: Insights from the Israel Defense Forces in Lebanon and Gaza* (RAND Corporation, 2010).

Ambassador Gopalaswami Parthasarathy is visiting professor at the Centre for Policy Research, New Delhi. Ambassador Parthasarathy retired in 2000 from a long career in the Indian foreign service, before which he served as a commissioned officer in the Indian Army. He has served as India's high commissioner to Cyprus (1990-92), ambassador to Myanmar (1992-95), high commissioner to Australia (1995-98), and high commissioner to Pakistan (1998-2000), among other senior diplomatic assignments. In addition to his current position at the Centre for Policy Research in New Delhi, he is also visiting professor of international relations at the University of Punjab, Chandigarh, India; senior fellow at the Centre for Strategic and International Studies; and a member of the executive committee of the Centre for Air Power Studies in New Delhi. Ambassador Parthasarathy writes on foreign policy and national security issues for a number of newspapers and news agencies in India and abroad. He is on the Panel of Experts from India for the ASEAN-India Track-II Dialogue. He is also a member of the Indian delegation to the high-level Indo-US Strategic Dialogue organized by the Confederation of Indian Industries and the Aspen Institute.

Dr. Gérard Prunier is a historian and senior researcher at the Centre National de la Recherche Scientifique in Paris, specializing in the Horn of Africa as well as Central and East Africa. He holds degrees in political science from the École Libre des Sciences Politiques and in sociology from the University of Nanterre, as well as a Ph.D. in African studies from the Ecole des Hautes Etudes en Sciences Sociales, University of Paris. Prunier was seconded to the Ministry of Foreign Affairs from 2001-06 to head the Centre Français des Etudes Ethiopiennes in Addis Ababa, Ethiopia. Dr. Prunier has written extensively about Africa with a special focus on Congo, Eritrea, Ethiopia, Kenya, Rwanda, Somalia, Sudan, and Uganda. His many books and articles have been translated into English, French, and German.

Colonel Dirk Rogalski is a career officer in the German army and has served as a visiting lecturer in the Department of National Security Affairs at the Naval Postgraduate School since 2009. He received his Master of Arts from the University of the German Armed Forces, Munich, and has a background as a fighter pilot in the Luftwaffe. After graduating from the German Armed Forces General Staff Course in Fuehrungsakademie, Hamburg, in 1991, he held a variety of national and international leadership and staff positions, most recently as chief of staff of the 2nd Air Division, which included a deployment to HQ ISAF, Kabul, Afghanistan. His expertise centers on European security and defense policy, and relations among NATO, the United States, and the EU.

Dr. James A. Russell is associate professor in the Department of National Security Affairs at the Naval Postgraduate School where he teaches courses on Middle East security affairs, terrorism, and national security strategy. He holds a master's degree in public and international affairs from the University of Pittsburgh and a Ph.D. in war studies from the University of London. Prior to joining the Department of National Security Affairs in 2001, Dr. Russell held a variety of positions in the Office of the Assistant Secretary of Defense for International Security Affairs, Near East South Asia, Department of Defense. During this period he traveled extensively in the Persian Gulf and Middle East working on US security policy. His most recent book is *Innovation, Transformation, and War: Counterinsurgency Operations in Anbar and Ninewa Provinces, Iraq, 2005-2007* (Stanford University Press, 2010).

Dr. Eitan Shamir is head of department in the division of National Security Doctrine at Israel's Ministry of Strategic Affairs and a research fellow with the Begin-Sadat Center for Strategic Studies at Bar Ilan University. He was formerly a senior fellow at the Dado Center for Interdisciplinary Military Studies, Israel. His research focuses on command and leadership, sources of military change, and military culture. He is the author of *Transforming*

Command: The Pursuit of Mission Command in the US, UK and Israeli Armies (Stanford University Press, 2011). Dr. Shamir has taught at the IDF Staff & Command College, IDF Operational Art Course, and the IDF Junior Officers Program at Bar Ilan University. He also has worked internationally as a management consultant with firms such as PwC and KPMG Consulting, focusing on strategic transformations and leadership development. He holds a Ph.D. from the Department of War Studies, King's College, London.

Lieutenant-Colonel Karsten Struss joined the German Army as an artillery officer cadet in 1988. He graduated from the University of the German Armed Forces in Munich in 1995 with a degree in geodetic engineering. He later served in the Geographic Service of the Bundeswehr, including assignments as platoon leader and battery commander on operations in the Balkans. He later completed the German General Staff Course at the Command and Staff College in Hamburg, after which he served in the Operations Division of 1 German/Netherlands Corps, the Policy and Strategy Division at the German Ministry of Defense, and as a battalion commander. In addition to his engineering degree, Lieutenant-Colonel Struss holds a Master of Defense Administration from Cranfield University, and a Master of Arts in Security Studies from the Naval Postgraduate School. Beginning in August 2011, he will be assigned to the Joint Operations Staff at the German Ministry of Defense.

Dr. Mikhail Tsypkin is associate professor in the Department of National Security Affairs at the Naval Postgraduate School. Prior to joining NPS in 1987, he served as the Salvatori Fellow in Soviet Studies at the Heritage Foundation in Washington, DC. Dr. Tsypkin has a Ph.D. in political science from Harvard University and is a member of the Scientific Board of the online journal *The Journal of Power Institutions in Post-Soviet Societies*. Dr. Tsypkin has published numerous articles on Soviet and Russian military affairs.
