Protesters converge on a major intersection at 11S NV 43655 09895 and begin building barricades near the National Justice Center building. One of your soldiers reports that he counted 500 protesters, while another Soldier heard reports from locals that 300 more were coming from outside the city in a caravan. The people are holding signs that complain about high cost of living and fuel prices. Some of the people in the crowd are yelling while carrying baseball bats and large sticks.

Vehicle traffic has been very sparce this morning and a local civilian named Miguel Abacha approached you, saying people can't get through. Your unit received reports of a major land slide, so you deployed your unit's drone to capture this image. You notice that the landslide has occurred on the north-west side of the road. The intersection is obstructed by mud and water has flooded one portion of the road. The drone captured the image at 11S NV 25532 07309. The water flow indicates that a large crack has formed in the road. The population cut off is approximately 6,000 people. Abacha was trying to get back to the village of Egnar that was cut off.

Typhoon Sebastian has passed through your area and destroyed approx. 50% of the homes within the town of Tortuga at 11S NV 28174 01973. Your unit is called to respond and finds that the two main roads (Route 22 and Route 35) that enter the town have been flooded. Electricity has been cut off to the town. A main sewage line has broken, and the water supply appears to be contaminated. While medical units are present, they are not able to move about the town due to flooding. You find that the city hall was flooded but has dried up and could be a good location to set up a medical facility and water distribution site at grid 11S NV 29586 01294 / 35.2543° N, 116.6748° W.











Your unit receives information from a local trucker, Ron Romeo, that a mining operation has started in the costal hills outside of the town of San Palo. A drive to the north of the town reveals the scenes above. When questioned, the workers all direct you to a foreman named George Michaels who says he works for Fodeco Corp. and has permits for the mining. You deploy your unit's drone to gather the arial image provided here. Your personnel count 15x medium trucks, 11x D7 Bulldozers, and 2x Landing Craft Tank 72M12. The Drone marks its landing point as 11S NV 37959 05816.

The chase was approximately three blocks south of your current location at the clinic.

#### Defector

Your unit is operating in an area known for terrorism and anti-government uprisings. As you patrol, an armed woman approaches but throws up her hands when she sees your soldiers. When she and her brother had a disagreement with the group leadership, she was threatened and her brother was killed. The group coerced her to continue fighting for the cause. She had heard radio transmissions and her father's voice was on a show called "Voice of Hope." The guerilla group overheard the message and threatened to kill her family if she left. She felt the urge to leave when she saw a social media post from your unit inviting defectors to enjoy a hot meal and acceptance for leaving the group. You take her in for questioning.

Your call sign is Rooster-6

Your unit receives a notice through an anonymous tip reporting line. The tip provides contact information for a local fisherman, named Mike Kotsuma, who owns a small warehouse near the fishing pier. After coordination you meet up with Mr. Kotsuma. During the meeting, he states he fishes from night into the early morning and sells the catch in the market the morning and afternoon. For the past four months, he says he has been harassed by other fishing boats that have no national flag. They spray water cannons and shoot guns into the air to scare him and his crew off. He gives the location of 21.8415° N, 160.5685° W as the last location this happened at but notes that it happens for miles around that area. He is unsure what to do but saw a message on Telegram inviting locals to share suspicious activity. He provides a photo of some of the boats that have harassed his boat and others in the area. He notes the photo was taken at the location he provided.

You were sent to work with a local security force on the edge of a conflict area. As you arrive at the unit and pass through security at 11S NV 29879 03492/35.2741° N, 116.6715° W, a Mid-leader speaks to you. He reports that the unit of 200 is at 60% capacity. Training is going well, but due to the location, they need a new intelligence officer and are more vulnerable to attack due to the deployment of one detachment to the coast. Weapons qualification was lower this month than last. Trucks on patrol have had repeated flat tires within 10 minutes of leaving the gate. The unit is working to understand whether this is from sabotage, or due to dry-rot. The unit has initiated two engagement activities at nearby villages and were told by the village elder that the electricity has been out for two weeks, leading to frustration in Apple Village at 11S NV 33251 03038. Talking to the military officer at Pineapple Village 11S NV 43487 09792/35.3304° N, 116.5215° W noted a nearby elder stated that the sewage plant was sabotaged by an insurgent group last week, which led to civil unrest. Small generators are in use by business owners and families but fuel is limited.
